

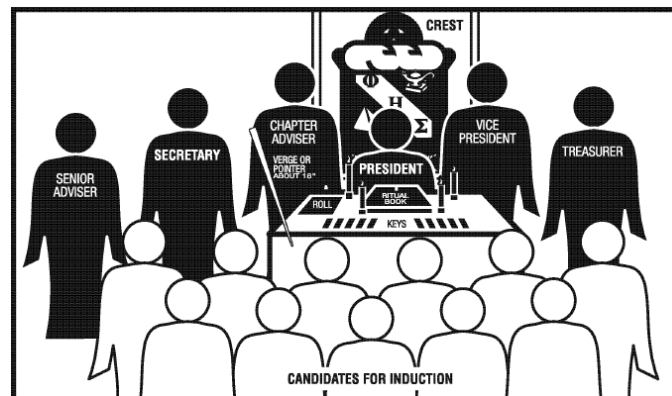

Induction Ceremony Recommended Setup

1. The induction of new members into the Society shall be open to non-members.
2. The recommended properties for the induction ceremony are:
 - a. The official Society Crest (this could be framed, with a glass cover, and mounted in a place in full view of the inductees and audience members).
 - b. Booklet containing the induction ceremony ritual guidelines (this document).
3. The following additional properties are optional, but could enhance the ceremony.
 - a. A table, with suitable cloth cover.
 - b. A verge or pointer.
 - c. Academic gowns for the participating officers and chapter advisor.
 - d. Three or more candles, in holders.
4. An explanation of the crest and key must be included as part of the ceremony.
5. The history of Phi Eta Sigma must be included as part of the induction ceremony, or in an orientation session prior to the induction. This requirement could be satisfied by a brief statement about Phi Eta Sigma at the initiation dinner or reception, if one is held.



6. The inductees must respond to the objectives of the Society in an affirmative manner.
7. Any local customs, history, or traditions may be inserted into the induction ceremony is desired.

The Induction Ceremony

Senior Advisor [*or Designated Chapter Officer*]:

Phi Eta Sigma was founded at the University of Illinois in 1923 to recognize and promote superior scholarship among first-year students. Over the last century, the Society has established chapters at nearly 400 institutions of higher learning.

Phi Eta Sigma was originally a freshman men's scholastic honor fraternity having a formal grip, password, and secrets. In 1974, the Society dropped the word "fraternity," accepted all students regardless of gender into membership, and opened the induction ceremony to non-members. It is the honor aspect which we emphasize, stressing the academic nature of our organization.

Your induction is a traditional procedure during which we shall inform you of your responsibilities as a Phi Eta Sigma member. Although the original ritual has been modernized, the basic principles of the Society remain unchanged. Our chapter advisor, _____ [*insert chapter advisor name*] will begin the ceremony.

Chapter Advisor(s):

Membership in Phi Eta Sigma is an honor bestowed on those who, at the beginning of their collegiate careers, give promise of continued excellence in scholarship. Chapter President [*or Designated Chapter Officer*]:

Phi Eta Sigma emphasizes qualities which are essential to a successful and happy life. The person who succeeds must possess three important qualities: vigor and discipline of mind; care and respect for one's self; and above all, generosity of character.

Chapter Treasurer [*or Designated Chapter Officer 1*]:

A vigorous and disciplined mind is one of the first requisites of success. Those having great achievements as goals must be able to think comprehensively, logically, and accurately. Thorough mental training is required to accomplish this.

Chapter Secretary [*or Designated Chapter Officer 2*]:

Respecting one's self means treating yourself with dignity and meaning. Achieving holistic health allows you to provide service to the community. The trained mind without care and respect falls short of its possibilities.

Chapter Vice President [*or Designated Chapter Officer 3*]:

Character is the foundation of responsibility and success. It is the basic link between respect for one's self and discipline of mind. The qualities of character which we emphasize are: truth and helpfulness in our relations with others, courage to uphold your principles, and constructive thinking.

Chapter President [*or Designated Chapter Officer*]:

Wellness is the complete integration of mind, body, and spirit. Candidates, these are the qualities which we emphasize. If you accept these qualities as guidelines for your future life, answer, "I will."

Inductees:

(answering in unison): I will.

Chapter President [*or Designated Chapter Officer*]:

(Addressing the chapter advisor): What is your recommendation concerning these candidates?

Chapter Advisor(s):

President [*first and/or last name*], I find that they merit membership in a society which celebrates academic achievement, values vigor and discipline of mind, care and respect for one's self, and above all, mobility and generosity of character. Never before have the peoples of the world given so much attention or prestige to academic training, or placed so much faith in the minds of academic scholars.

May these candidates continue in this path to further achievements on our campus and to grater service to other students and citizens.

Chapter President [*or Designated Chapter Officer*]:

Phi Eta Sigma is an honor society composed of individuals with high ideals seeking companionship and fellowship. I am happy to welcome you into their company, and to instruct you on the meaning of our crest.

The crest presents the symbols of the Society. The torch and book are emblematic of scholarship; the pyramid, of strength; and the gold star, of noble character. The chain links the symbols together, indicating that all three must be combined in a person who would attain the highest development. The Greek words on the scroll form the motto of the organization: "Knowledge is Power."

The pin displays the colors of the society. On a background of gold there appear, in black enamel, are three Greek letters which form the name of our Society: Phi, Eta, and Sigma. These are the initials of the words Φίλοι Ἡβηδόν Σοφίας (pronounced Phé -loy Hay-bay-done So-phé-as). They represent the basis of our selection of members in that they literally mean “Lovers of Wisdom.”

As you accept membership, I charge you as new members of Phi Eta Sigma to be ever mindful of the three qualities which our golden key symbolizes: vigor and discipline of mind; care and respect for one’s self; and above all, generosity of character.
